VPAE

- Zahide gave an update on what she worked on over the summer. These projects include:
 - o Internal and external advocacy projects
 - o Changes to the ASU website
 - o Helped to find students to sit on Senate and other University Committees
 - Worked on academic appeals
 - Sat on Students Nova Scotia (SNS) and the Canadian Alliance of Student Associations (CASA)
 - o Attended the Maritime Student Congress (MSC)

VPEP

- Tove gave an update on what she worked on over the summer. These projects include:
 - Planning Welcome Week Welcome Week had a record number of attendees with 250 students at an event predicted for 50 and 500 students at the tailgate
 - Implementing new, interactive elements to Welcome Week (for example, passports, conversation starters, tote bags for the first 50 students to attend events)
