5. Standing Items

- a) Committee Chairs
- Zahide provided insight into her experience at the Students Nova Scotia Advocacy Week. She noted large budget cuts and an importance in making careful requests of the government considering this.
 - b) President
- Yash informed the council he and Zahide went to the Students Nova Scotia Advocacy Week in Halifax, where they had the opportunity to meet with MLAs to discuss student issues. The issues they covered include:
 - Student housing—advocated for the removal of the fixed-term lease loophole on rental properties and campus-specific housing strategies to increase/improve on campus housing
 - Financial support increases—advocated to change financial aid requirements to reflect fewer hours of work per week (6-7 hours per week), or to increase the financial aid pot
 - O Student health care—advocated for more accessible/increased on-campus healthcare options (one doctor per 1000 students, one emergency appointment per day, monthly pop-up travel clinics) and easier access to MSI for international students (the removal of the 13 months wait period and extending coverage from one year to two).
 - Integrated work and learning—advocated for a clearer post-secondary education model for Co-op students
- Yash also noted that he, along with Zahide, attended the Provincial Assembly where two bills which will affect students were passed:



- 1. Previously, universities facing extreme financial hardship received financial aid from the provincial government; this allowed the government to dictate changes to the universities who receive this funding. Now, the provincial government may intervene at any time without the request of the universities.
- 2. Executive members on university Board of Governers committees will have the authority to decide how to allocate seats to additional board members.
- Yash provided an update from Dr. Hennessy regarding the pool closure. The university administration is not interested in funding a temporary pool out of the concern such a project would lower the use of a future pool in a separate location.
 - c) Chair of Council
- The Governance Committee met and edited Article 2 of the ASU constitution. These edits will be reviewed by the General Manager before they are presented to the council for adoption.
